**Article I**

## **Article VI Prohibited Acts**

Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to carry on 1. By an organization exempt from Federal Income under Section 501 (c)(3) of the Internal Revenue Code or 2. By a corporation contribution to which are deductible under Section 170 (c) (2) of the Internal Revenue Code. No substantial part of this organization shall carry on any propaganda, or otherwise attempt to influence legislation, and this organization shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.

## **Article VII**

### **Distribution of Assets upon Dissolution**

In the event of dissolution, the assets of this organization shall be turned over to one or more organizations which themselves are exempt as corporation described in Section 501(c)(3) and Section 170 (c)(2) of the Internal Revenue Code of 1954 or corresponding Section of any prior or future law or to the Federal State or Local Government for exclusive public purpose. Said corporation is organized exclusively for charitable and educational purposes, including for such purpose, the making of distributions to organizations that qualify as exempt, organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding provision of any future United Stat Internal Revenue Code of 1986 or the corresponding provision of any future United State Internal Revenue Law.

## **Article VIII**

### **Duration of the Organization**

Existence of this organization shall commence on the date of filling of these Articles of Incorporation by the Department of State and this organization shall exist perpetually unless dissolved according to law.
